

Thank you for your interest in the Evening Cosmetology Program, Master Instructor at Meridian Technology Center. This program is designed for adult students who intend to pursue a career in Cosmetology.

Invitation to enroll in the program is through a competitive application process based on a point system. Points are earned in various ways including submitting a completed application, letters of recommendation, etc. Those interested should complete and submit the application along with all required documentation no later than April 15, 2023 to be considered.

Once applications are received and points are assigned, individuals with the most points will be invited to campus for an interview. During the interview, candidates will receive points for their response to each question, their professionalism, etc. While on campus for the interview, candidates will also complete an assessment on math, reading for information, and science, based on the National Career Readiness assessment. Those who collect the highest combined points from the interview, assessment, etc. will be invited to enroll in the program.

Those who are invited to enroll will be notified by phone, those who are not invited at this time will be notified by phone and are eligible to apply again during the next application period.

Program tuition for Master Instructor is \$3,000.00 (tuition is doubled for out-of-district students) – included in this tuition is a non-refundable \$500.00 deposit that must be submitted at the time of enrollment and is deducted from your final tuition payment. First tuition payment of \$750.00 is due by the first night of class. The cost of books are included in the tuition cost.

Additional program costs are approximately \$135.00 and include your State Board of Cosmetology fees, etc. These program costs are estimates, subject to change, and are non-refundable once paid.

One of the most important aspects of this course is attendance. The State Board of Cosmetology requires 1,000 clock hours for Master Instructors to be eligible for licensure. For the purposes of the State Board of Cosmetology, there are no excused absences. The year-round Evening Cosmetology class times are Monday - Thursday 4:00 pm - 10:00 pm. Being tardy or leaving early can also affect your accumulation of hours.
